

ACCESS SERVICE

3. Carrier Charge Access Service

The Telephone Company will provide Carrier Charge Access Service (Carrier Charge Access) to customers in conjunction with Switched Access Service provided in Section 6. of this tariff or the appropriate Switched Access Service section of other Access Service tariffs.

3.1 General Description

Carrier Charge Access provides for the use of end users' Telephone Company provided common lines by customers for access to such end users to furnish Interstate Communications.

A Special Access Surcharge, as set forth in 7.4.2 following, will apply to interstate special access service provided by the Telephone Company to a customer, in accordance with regulations as set forth in 7.4.2 following.

3. Carrier Charge Access Service (Cont'd)

3.2 Limitations

3.2.1 Exclusions

Neither a telephone number nor detail billing are provided with Carrier Charge Access. Additionally, directory listings and intercept arrangements are not included in the rates and charges for Carrier Charge Access.

3.2.2 Access Groups

All line side connections provided in the same access group will be limited to the same features and operating characteristics.

3.2.3 WATS Access Lines¹ - Grandfathered

Where Switched Access Services are connected with Special Access Services at Telephone Company Designated WATS Serving Offices for the provision of WATS or WATS-type Services, Switched Access Service Minutes which are carried on that end of the service (i.e., originating minutes for outward WATS and WATS-type services and terminating minutes for inward WATS and WATS-type services) shall not be assessed Carrier Charge Access per minute charges with the following exception. Carrier Charge Access per minute charges shall apply when Feature Group A or Feature Group B switched access is ordered from a non equal access telephone company office that does not have measurement capabilities and the assumed average access minutes, as set forth in the exchange carrier's access tariff are used.

3.3 Undertaking of the Telephone Company

3.3.1 Provision of Service

Where the customer is Switched Access Service under other sections of this or other Access Service tariffs, the Telephone Company will provide the use of Telephone Company common lines by a customer for access to end users at rates and charges as set forth in 3.5.1 following.

3.4.1 Switched Access Service Requirement

The Switched Access Service associated with Carrier Charge Access shall be ordered by the customer under the appropriate sections of the exchange carrier's access tariff.

3.5 Rate Regulations

3.5.1 Carrier Charge (CC)

(A) The CC charge represents a dollar amount, per access line, that the Telephone Company will collect from all toll providers. The Telephone Company will multiply the per line rate by the number of access lines for the month. This total represents the total intrastate CC amount to be recovered from toll providers. This amount will then be recovered from toll providers, based on their relative originating usage for the prior month.
