LOCAL EXCHANGE SERVICEA. APPLICATION OF TARIFF

1. This Tariff contains the schedule of rates and specific regulations applicable to local exchange telephone service furnished within all exchange areas in Pennsylvania served by Commonwealth Telephone Company. The rates and charges associated with other classes of service and facilities not specifically shown in this Tariff are given in Tariff Telephone - PA P.U.C. No. 23.
2. The schedule of rates, as shown in B. following, for each exchange area was based on a census of the local calling area for that exchange.
3. When the Company proposes to change an exchange area from one rate group to another because of an increase or decrease in the total number of main access lines in the local calling area, notice of the reclassification of said exchange to the proper rate group shall be given by filing revised tariffs with the Pennsylvania Public Utility Commission in accordance with the rules and regulations of the Commission. Such revised tariffs will be filed only (1) when an exchange area has exceeded or fallen below its rate group limitation as determined on two consecutive semi-annual reviews, to be conducted on April 1 and October 1 of each year, provided that the most recent of the two consecutive reviews exceeds the lower limit or falls below the upper limit of the new rate group by at least two percent or (2) when an additional exchange area is added to the local calling area of an exchange, and the number of main access lines of the new exchange local calling area exceeds the upper limit of the rate group. 4. Within the base rate area as shown on Maps, Section 2, the base rates for PBX trunks, one-party, two-party and four-party service apply in the exchanges as shown in B. following.

A. APPLICATION OF TARIFF (cont.)

5. Business and residence one-party, two-party, and four-party local exchange services consist of an exchange access line terminated in a standard modular jack or other appropriate connector. Rates shown in Section 6 of Tariff Telephone - PA P.U.C. No. 23 of this Company are applicable for telephone instruments leased from the Telephone Company.
6. The following schedule appearing in Section 1, Sheets 3 and 4, shows for each rate group presently utilized by the Company, (1) the parameters for each rate group, (2) each class of service offered in each rate group, (3) the rates applicable to the various classes of service in each rate group and (4) a list of the exchanges presently in each rate group.

LOCAL MEASURED SERVICE (LMS)

A. GENERAL

LOCAL MEASURED SERVICE (LMS) provides unrestricted calling within the existing local calling area from which the customer is charged a basic monthly line rate in addition to usage rates. When LOCAL MEASURED SERVICE is offered in an exchange area, the service is optional for residence and business one-party or PBX trunk customers on either a measured or metered usage basis.

Residence and business one-party or PBX trunk customers may choose between two optional arrangements for (LMS).

1. MEASURED SERVICE: Customers are charged a basic monthly line rate in addition to usage rates which are based on the number of messages, the duration of the messages, the distance to the called party, and the time of day the messages are originated.

The rules and rates for the measured service option are found in (C) following.

2. METERED SERVICE: Customers are charged a basic monthly line rate in addition to usage rates which are based on the number of messages and the time of day the messages are originated.

The rules and rates for the metered service option are found in (D) following.

B. REGULATIONS

1. LOCAL MEASURED SERVICE is subject to all regulations in this Tariff and other tariffs of this Company.

2. Availability of Service:

- a. LOCAL MEASURED SERVICE is offered in the following exchanges:

Lewisberry Dallas

- b. LOCAL MEASURED SERVICE will be provided to residence and business one-party or PBX trunk customers as an optional service, either on a measured or metered basis.

- c. LOCAL MEASURED SERVICE will not be provided for Foreign Exchange (FX) service. (C)

B. REGULATIONS (cont.)

3. All calls to the Telephone Company Business Office, Repair Service, or Local Directory Assistance, and 911 Emergency Service will be exempt from usage charges.
4. Each call to a telephone number within the customer's local calling area is charged on a usage basis. Usage charges apply on customer dialed, station-to-station local calls and are charged to the calling party.
5. Customers have the option of retaining current flat rate telephone service or changing to LOCAL MEASURED SERVICE (LMS), either MEASURED SERVICE or METERED SERVICE.
6. All customer lines at a given location where LMS is provided must be arranged with LOCAL MEASURED SERVICE, either MEASURED SERVICE or METERED SERVICE and equipped for outward calling.

1. Basic monthly line rates apply in addition to measured usage charges for residence and business one-party service or PBX trunk in the exchange where the service is available.

The above recalculations will be submitted to the Commission within 10 days after the occurrence of the event or date which occasions such recomputations. If the recomputed surcharge is less than the one in effect, or if the recomputed surcharge is more than the one then in effect, the utility may submit with such recomputation, a tariff or supplement to reflect such recomputed surcharge, the effective date of which shall be 10 days after filing.
